The In Home Care (IHC) program is part of the child care package and provides flexible care that supports families' workforce participation and child care requirements where other options are not available or appropriate. The IHC program is a capped program of up to 3,200 places, providing up to 100 hours of subsidised care per child per fortnight with a family hourly rate cap, subject to Child Care Subsidy and Additional Child Care Subsidy eligibility criteria.
